

Level Up Your Mancave Giveaway
OFFICIAL RULES AND LEGAL DISCLAIMER

1. By entering, attempting to enter, or in any way participating or attempting to participate in the Level Up Your Mancave Giveaway (the “Sweepstakes”), the participant (“Participant”) agrees to be bound by these Official Rules and Legal Disclaimer and the decisions of Bonneville International Corporation (“Administrator”) relating to the Sweepstakes, which are final and binding in all respects.

2. The Sweepstakes is put on by KKFN FM (the “Station”).

3. **NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

4. **HOW TO ENTER:** Beginning on March 31, 2025, at 12:00 a.m. Mountain Time through April 18, 2025, at 11:59 p.m. Mountain Time, download the free Denver Sports app in the IOS or Android store, open the app, click on the banner for the Level Up Your Mancave Giveaway and follow the on-screen entry instructions. Fill in all required information. No more than one entry per person or email address is permitted. Use of multiple email addresses or identities or of any robotic, automatic, or programmed entry method will result in disqualification.

5. **ELIGIBILITY:** The Sweepstakes is open to individuals who (a) are residents of the 50 United States and D.C., (b) are 18 years of age or older at the time of entry, and (c) reside within Station’s listening area, except for (i) employees of Station, and their affiliates, subsidiaries, and agencies (collectively the “Promotion Parties”), and members of their immediate family or persons living in the same household; and (ii) individuals who have won a prize having a value greater than \$500 in a contest or sweepstakes administered by Station during the ninety-day period preceding the first day on which entries may be submitted in this Sweepstakes.
